Cancellation Policy

Service Cancellation: Please notify Pets and Wildlife Services AU Pty Ltd of any cancellations or changes to service requirements, a minimum of 24 hours ahead of the scheduled and allocated appointment time. Failure to do so will incur a cancellation fee of 50% of the scheduled service fee.

Cease of Service

In the event that Pets and Wildlife Services AU Pty Ltd cease the service of scheduled treatment due to patient stress, behaviour, aggression or risk of injury to self or others, a cancellation fee of 50% of the scheduled service fee will incur. Pets and Wildlife Services AU Pty Ltd will discuss options with you regarding the scheduled service that will be in the best interest for your pet.

Rates, Fees, and Charges

You will be advised of the rate, fee, and charges prior to commencement of your scheduled service. Additional charges may apply for out of hours, emergency assistance, weekend rates and public holiday rates.

Bank Fees

On finalising payment by Debit or Credit, bank fees will apply and will vary depending on the type of bank card used and the bank the card is associated with.

Privacy Policy

Storage of Information

Restraint Policy

In the case where medications, instructions and referral form are not available, Pet and Wildlife Services AU Pty Ltd reserve the right o refuse service but will make every attempt to contact the prescribing Veterinarian to discuss and obtain advice and instruction.
